KNOW ALL MEN BY THESE PRESENTS, that I, Walter Arnold,

in consideration of Six Hundred (\$600.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James C. Sullivan and Carrie H. Sullivan, their heirs and assigns, forever, the following described property:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as the northeastern one-half of Lot No. 8, on a plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R. M. C. Office for Greenville County, in Plat Book "AA", at page 187, and having according to said plat the following courses and distances to-wit:

BEGINNING at the joint corner of Lots 9 and 8 on the west side of Gandy Street and running thence with the west side of Gandy Street S. 43-0 W. 30 feet to a point, the center of Lot No. 8; thence N. 47-0 W. approximately 116 feet to a point in the center of the rear line of Lot No. 8; thence N. 82-05 E. 39.2 feet to a point at the rear corner of Lot No. 9; thence with the common line of Lots Nos. 8 and 9 S. 47-0 E. 90 feet to an iron pin on the west side of Gandy Street, the point of beginning.

The intent and purpose of this deed is to convey exactly one-half of Lot 8, which one-half is the northeastern one-half of Lot No. 8.



together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
