ALL that lot of land with the buildings and improvements thereon, situate on the South side of Watts Avenue, in the City of Greenville, in Greenville County, South Carolina, being shown as portion of Lots 32 and 33 on plat of property of Mrs. S. K. Tindal Estate, recorded in the RMC Office for Greenville County, S. C. in Plat Book "H", page 235, and having according to a plat made by A. C. Crouch, January 17, 1950, and said recorded plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Watts Avenue at point 130 feet West of the Southwest corner of the intersection of Watts Avenue and Brook Drive, joint front corner of Lots 18 and 32; thence along the joint line of Lots 18 and 32, S. 5-10 W., 142.3 feet to an iron pin at joint rear corner of said lots; thence along the rear line of Lot 32, S. 89-57 W., 34.9 feet to an iron pin; thence along a line across lots 32 and 33, N. 22-45 W., 125.1 feet to an iron pin on the South side of Watts Avenue; thence along the South side of Watts Avenue, N. 70-0 E., 30 feet to an iron pin; thence continuing along, the South side of Watts Avenue, N. 76-45 E., 70.1 feet to the point of beginning.
