the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **Bessie C. Traynham, her heirs and assigns forever:**

ALL that certain lot of land, with improvements thereon, situated in the Town of Simpsonville, County of Greenville, State of South Carolina, being known and designated as Lot No. 13 of Howard Subdivision, in accordance with plat by Lewis C. Godsey dated July 21, 1956, and being more fully described in accordance with said plat, to-wit:

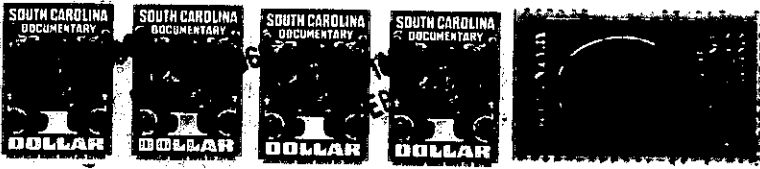
