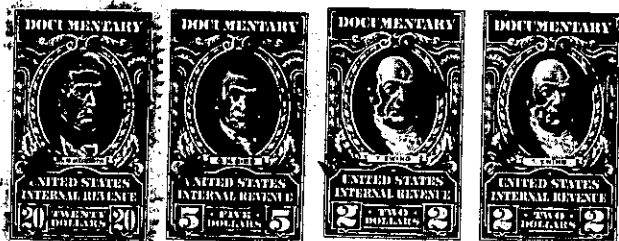
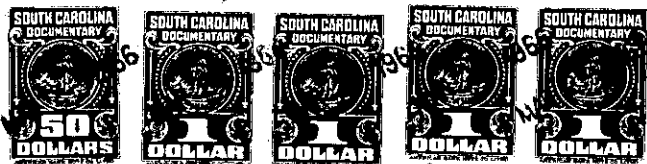

All that lot of land situate on the west side of Pimlico Road, in the city of Greenville, Greenville County, state of South Carolina, shown as Lot No. 461 on plat of Section D of Gower Estates, made by R. K. Campbell and Webb Surveying and Mapping Co., May 1964, recorded in the RMC Office for Greenville County S. C., in Plat Book RR at pages 192 and 193, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Pimlico Road at the joint front corner of Lots 460 and 461 and runs thence along the line of lot 460, N. 58-38 W. 214.2 feet to an iron pin; thence N. 6-26 E. 37 feet to an iron pin; thence N. 2-35 E. 25 feet to an iron pin; thence with the line of Lot 462, S. 79-43 E. 186.7 feet to an iron pin on the west side of Pimlico Road; thence along the west side of Pimlico Road S. 2-35 W. 140 feet to the beginning corner.

This is the same lot conveyed to grantor by Conyers & Gower, Inc. by deed recorded Oct. 7, 1965 in deed book 783 page 511 of the RMC Office for Greenville County, S. C., and is conveyed subject to building restrictions applicable to said subdivision recorded in deed book 753 page 571, and also to the drainage easement along the southern edge of this lot.
