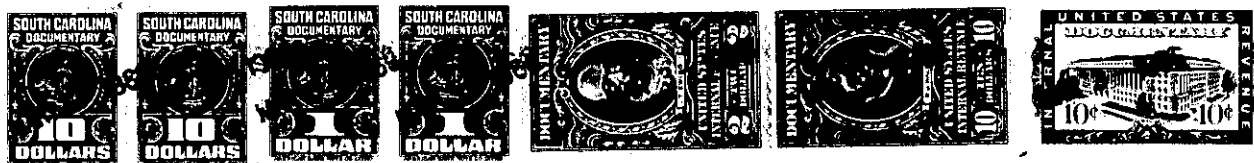
All that certain piece, parcel, or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the Eastern side of Holmes Drive and being known and designated as Lot No. 2 on Plat of Holmes Acres, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "Z", at Page 1, and having, according to said Plat, the following metes and bounds, to wit:

Beginning at an iron pin on the eastern side of Holmes Drive, joint front corner of Lots Nos. 1 and 2 and running thence with the common line of said lots S. 86-20 E. 151.3 feet to an iron pin; thence across the rear line of Lot No. 2 S. 23-28 E. 81.5 feet to an iron pin; thence with the common line of Lots Nos. 2 and 3 S. 88-15 W. 175.3 feet to an iron pin on the eastern side of Holmes Drive; thence with said Drive N. 4-56 W. 90 feet to an iron pin, the point of beginning.
