That WE, GEORGE D. STEWART AND HENRY VAUGHN

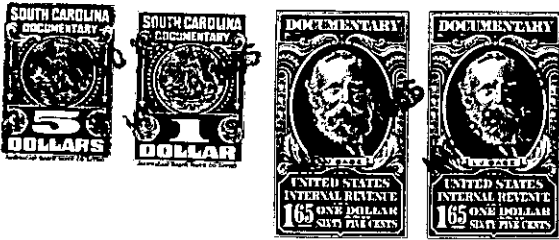

THE CITY OF GREENVILLE, SOUTH CAROLINA, ITS SUCCESSORS AND ASSIGNS FOREVER:

ALL 6" C.I. and 2" galvanized water lines and appurtenances in Rosewood Park Subdivision that lie in the Taylors Water and Sewer District. The water lines and appurtenances conveyed herein consist of 606' of 6" C.I. Pipe; 1-6" Valve; 1019' of 2" galvanized pipe; 4-2" valves, all as shown on Plat entitled "George D. Stewart to City of Greenville", attached hereto and made a part of this conveyance.

TOGETHER will all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines and appurtenant equipment.
