KNOW ALL MEN BY THESE PRESENTS, that I, Edwin R. Watkins,

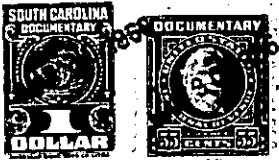
in consideration of Five Hundred and no/100 - - - - - Dollars,

C. at the North-western corner of Greenbrier Drive and Frontage Road of U. S. Highway No. 276 and being known and designated as Lot No. 1 on plat of Greenbrier, Sections 1 and 2, recorded in the R.
