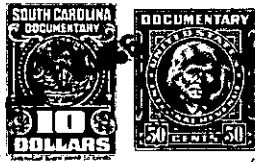
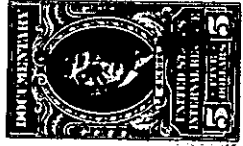

KNOW ALL MEN BY THESE PRESENTS, that W. E. Caldwell, individually and as Trustee,

in consideration of Five Thousand and 00/100 (\$5,000.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto White Transportation Corporation, its successors and assigns forever:

ALL that tract of land lying in the State of South Carolina, County of Greenville, being known as 90.80 acres, shown as Lot No. 3 according to a plat of property of George Ross, dated March 1942, and recorded in the R.M.C. Office for Greenville County in Plat Book Q, at page 29, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Northern side of Talley Bridge Road at a branch; thence with same, N. 7-15 E. 170 feet to an iron pin; thence Due East 186 feet to an iron pin; thence N. 35-45 E. 360 feet to an iron pin; thence N. 50-10 E. 187 feet to an iron pin; thence N. 67-50 E. 468 feet to an iron pin; thence N. 56 E. 191.8 feet to a sourwood; thence S. 1 E. 261.3 feet to an iron pin; thence N. 75-30 E. 382 feet to an iron pin; thence S. 65-30 E. 143 feet to an iron pin; thence N. 85 E. 117 feet to an iron pin; thence S. 24 E. 584 feet to an iron pin in or near a branch; thence following said branch as the line, S. 51-30 W. 235 feet to an iron pin; thence S. 81-15 W. 245 feet to an iron pin; thence S. 65 E. 215 feet to an iron pin; thence S. 40 E. 870 feet to a W.O. stump; thence S. 16 E. 1313 feet to an iron pin; thence S. 57 W. 500 feet to an iron pin; thence S. 62-30 W. 322 feet to a point in a branch; thence with the branch as the line, S. 82 W. 161 feet to an iron pin; thence S. 79 W. 149 feet to an iron pin; thence leaving said branch, N. 52 W. 715 feet to a hickory, thence N. 2 E. 638 feet to a hickory; thence N. 20-15 W. 804 feet to an iron pin; thence N. 78-30 E. 535 feet to an iron pin; thence N. 13-20 W. 527 feet to an iron pin in Talley Bridge Road; thence along the center of said road the following courses and distances, N. 75-45 W. 271 feet to an iron pin; thence Due West, 135 feet to an iron pin; thence N. 71-15 W. 238 feet to an iron pin; thence N. 82-45 W. 100 feet to an iron pin; thence N. 63-45 W. 86 feet to an iron pin on the Northern side of Talley Bridge Road; thence S. 67 W. 100 feet to an iron pin; thence in a Southwestern direction 32.5 feet to an iron pin; thence N. 85-35 W. 186 feet to the point of beginning. The Grantor herein was conveyed an undivided 1/2 interest in said property in his individual capacity by deed recorded in Deed Book 588, page 333, and the remaining undivided 1/2 interest was conveyed to the Grantor, as Trustee, by deed of (cont.)
