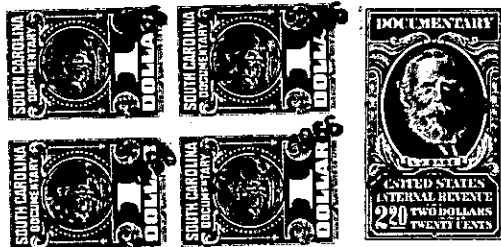
KNOW ALL MEN BY THESE PRESENTS, that I, WILLIAM M. EDWARDS,

in consideration of One Thousand Nine Hundred Sixty-five and 28/100 (\$1,965.28)-----Dollars,
paid by exchange of real estate,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto ALVIN TRAMMELL, his Heirs and Assigns, forever:

ALL that piece, parcel or lot of land located, situated and being on the north side of Wayne Drive in the County of Greenville, State of South Carolina, known as Lot No. 50 in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat of Dalton & Neves dated March, 1957, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book RR, Page 20 (Revised April 6, 1964, and recorded in Plat Book RR, Page 20) and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of Wayne Drive at the joint front corner of Lots Nos. 50 and 51 and runs thence along the line of Lot No. 51, N. 33-15 W. 173.8 feet to an iron pin; thence running N. 54-54 E. 100.05 feet to an iron pin at the joint rear corner of Lots Nos. 49 and 50; thence running S. 33-15 E. 177.1 feet to an iron pin on the north side of Wayne Drive; thence running along the north side of Wayne Drive, S. 56-45 W. 100 feet to the point of beginning.
