William W. Corwin and Shirley H. Corwin, their heirs and assigns forever:

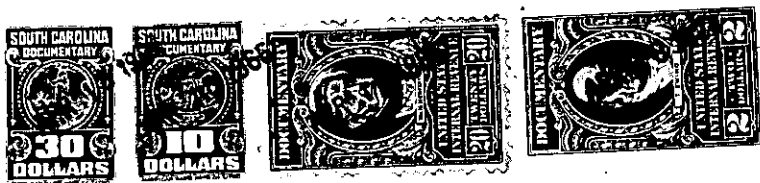
