BEGINNING at an iron pin on the eastern edge of Hastings Circle, joint front corner of Lots Nos. 40 and 41, and running thence along the eastern edge of Hastings Circle, following the curvature thereof, the chords being $N.\ 16-24$ W. 46.0 feet, N. 12=46 W. 44.0 feet, N. 6-55 W. 50.0 feet, and N. 4-35 E. 15.0 feet, to an iron pin at the corner of Lot No. 42; thence along the line of that lot, N. 85-03 E. 180.4 feet to an iron pin at the joint rear corner of Lots Nos. 35 and 36; thence along the rear line of Lot No. 36, S. 2-15 E. 95.6 feet to an iron pin at the joint rear corner of Lots Nos. 36 and 37; thence along the rear line of Lot No. 37, S. 6-26 E. 25.0 feet to an iron pin at the rear corner of Lot No. 40; thence along the line of that lot, S. 73-36 W. 165.1 feet to the beginning corner;
