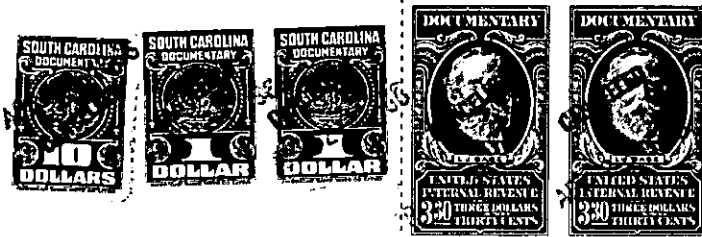
KNOW ALL MEN BY THESE PRESENTS, that Annabell P. Campbell
