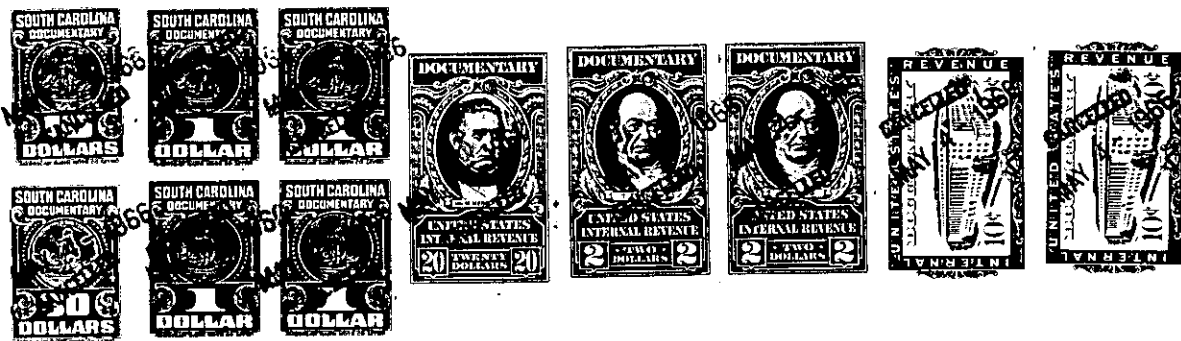
his, hers or their heirs or assigns forever:
