All that piece, parcel or lot of land in Greenville County, State of South Carolina being known and designated as Lot No. 101 on plat of Property of the Estate of Tully P. Babb, recorded in Plat Book QQ at Pages 162-163, in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Shelburne Road at joint front corner of Lots 100 and 101, and running thence with line of Lot 100 S. 12-49 W. 264 feet to an iron pin in line of Lot No. 102; thence with Lot 102 S. 86-45 E. 185 feet to an iron pin on Stonehaven Drive; thence with said Stonehaven Drive N. 5-22 E. 225 feet to an iron pin at the intersection of Stonehaven Drive; thence with the curve of said intersection N. 38-38 W. 36 feet to an iron pin on Shelburne Road; thence with said Shelburne Road N. 82-38 W. 126 feet to the point of the beginning.

This property is conveyed subject to the following restrictions:

- 2. No house shall be constructed on said lot containing less than 2200 square feet, exclusive of porches, carports and breezeways.
