All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Rollingreen Road, near the City of Greenville, being known and designated as Lot 48 on plat of subdivision known as Wellington Green as shown on plat thereof being recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 29 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Rollingreen Road said iron pin being the joint front corner of Lots 48 and 49 and running thence with the joint line of said lots, N. 30-44 E. 178.4 feet to an iron pin in the line of Lot 42; thence S. 57-23 E. 22 feet to an iron pin; thence S. 57-43 E. 78.1 feet to an iron pin, joint rear corner of Lots 47 and 48; thence with the joint line of said lots, S. 30-44 W. 175.7 feet to an iron pin on the northeastern side of Rollingreen Road; thence with the northeastern side of Rollingreen Road, N. 59-16 W. 100 feet to the beginning corner; being the same conveyed to us by Weldon F. Bowman by deed dated November 14, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 736 at Page 218.
