ALL THAT piece, parcel or triangular lot of land situate in Ward 5 of the City of Greenville, County of Greenville, State of South Carolina, on the northwest side of Willis Street and being more fully described as follows:

BEGINNING at an iron pin which is located S. 19-45 W. 150.35 feet from the intersection of Perry Avenue and Willis Street and running thence along Willis Street, S. 19-45 W. 48.65 feet to a point; thence running N. 69-25 W. 23.01 feet to an iron pin on the right-of-way of the new highway; thence running N. 45-17 E. along said right-of-way 55.59 feet to the point of beginning. This being the southern portion of the property acquired by grantor by deed dated February 17, 1955, recorded in the RMC Office for Greenville County in Deed Book 518 at Page 540.

BEGINNING at a point on the northwestern side of Willis Street, which point is located S. 19-45 W. 164 feet from the intersection of Perry Avenue and Willis Street, and running thence along Willis Street S. 19-45 W. 59.2 feet to a point; thence running N. 74-29 W. 53.58 feet to an iron pin on the right-of-way of the new highway; thence following the line of said right-of-way, N. 45-17 E. 70.3 feet to an iron pin; thence running S. 79-25 E. 23.01 feet to the point of beginning.
