KNOW ALL MEN BY THESE PRESENTS, that I, Winzer Clay

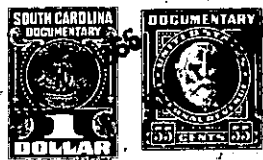
in consideration of Four Hundred (\$400.00) ----- Dollars,
