

All that piece, parcel or lot of land on the above mentioned plat located on the Eastern side of Tumbleweed Terrace and having the following metes and bounds, to wit:

Beginning at an iron pin on the Eastern side of Tumbleweed Terrace at the corner of lot number 54 and running thence along the Eastern side of said road or street N. 38-46 E., 1046 feet to an angle of said road on drainage ditch; thence still with said road N. 7-46 E., 85 feet to corner of Pinewood Drive; thence along the Southern side of Pinewood Drive N. 88-05 E., 200 feet; thence S. 1-55 E., 120 feet; thence S. 37-00 W., 1270 feet along Flynn Estate to an iron pin at rear corner of lot No. 54 on said plat; thence with the line of lot No. 54 N. 50-45 W., 320 feet to the beginning corner.
