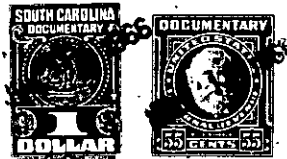

KNOW ALL MEN BY THESE PRESENTS, that I, W. E. Perry

in consideration of Three Hundred Twenty-Five & no/100 - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Anderson Durant his Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Grove Township, known and designated as Lot No. 5 on a Plat of the property of W. E. Perry prepared by R. K. Campbell, in March 1962, entitled "Final Plat Reedy Acres", duly recorded in the Office of the R. M. C. for Greenville County, S. C., and having according to said plat, the following courses and distances, to-wit:
Beginning at an iron pin in the western edge of the Fork Shoals Road, joint front corner with Lot No. 6, and running thence with the joint line of said Lot No. 6 S. 71-05 W. 200 feet to an iron pin back joint corner with Lot No. 6 on line of Lot No. 10; thence with the joint line of said Lot No. 10 N. 19-34 W. 87 feet to an iron pin, back joint corner with Lot No. 4; thence with the joint line of said Lot No. 4 N. 71-05 E. 200 feet to an iron pin in the western edge of the Fork Shoals Road, joint front corner with said Lot No. 4; thence with the western edge of said Fork Shoals Road S. 19-34 E. 87 feet to an iron pin, the point of beginning, and bounded by the Fork Shoals Road, other lands of the Grantor, T. Walter Brashier and Robert Lee Laster. This being a small portion of the land conveyed to the Grantor in a deed from Hattie D. Perry & C. O. Perry, Jr., on November 8, 1948 of record in the R. M. C. Office for Greenville County, S. C., in Deed Book 364, Page 194.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
