

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #22 of a subdivision known as Club View Heights according to a plat thereof prepared September 1956 by C. C. Jones and Associates, Engineers, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at Page 145 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Traynham Boulevard at the joint front corner of Lots 22 and 23 and running thence along the joint line of said lots, N. 62-52 E. 170 feet to an iron pin in the line of Lot 24; thence along line of Lot 24, S. 40-10 E. 41.4 feet to an iron pin in the line of Lot 20; thence along the line of Lot 20, S. 18-48 E. 60.2 feet to an iron pin at the joint rear corner of Lots 22 and 21 and running thence along the joint line of said lots, S. 62-52 W. 170 feet to an iron pin on the eastern side of Traynham Boulevard; thence with the eastern side of said Traynham Boulevard, N. 27-08 W. 100 feet to the point of beginning.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

As a part of the consideration, the grantee expressly assumes and agrees to pay the balance due and owing on a certain note and mortgage given by Donald E. Norris and Patricia L.
