Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and
- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County of Greenville , State of South Carolina, described as follows:

All that lot or land in Paris Mountain Township, Greenville County, State of South Carolina on Abelia Road, known as lot 4, Section 1 of Garrison Circle, plat made by Beeson & Scott, Engineers, on October 30, 1952, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on Abelia Road at the joint corners of lots 3 and 4 and running thence with said Road, S 64-55 W, 110 feet to the joint corners of lots 4 and 5; thence with the joint line of lots 4 and 5, N 25-05 W, 100 feet to the joint rear line of lots 4 and 5; thence N 64-55 E. 110 feet to the rear corners of lots 3 and 4; thence with the joint line of lots 3 and 4, S 25-05 E, 100 feet to the point of beginning and being the same property conveyed to me in deed book 592 at page 153

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
