KNOW ALL MEN BY THESE PRESENTS, that I, A. A. Drake, of Greenville County,

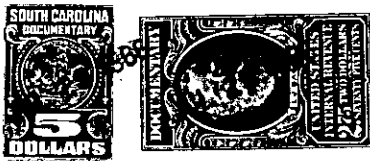

Tate, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown as Lot No. 19 on a Plat of Grand View Heights, recorded in the R. M. C. Office for Greenville County in Plat Book EE, Page 190 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Grand View Circle at the joint front corner of Lots 19 and 20 and running thence with the common line of said lots, N. 71-15 E., 241.7 feet to an iron pin; thence S. 1-20 E., 106 feet to an iron pin; thence S. 56-30 W., 100 feet to an iron pin on an alley; thence with said alley, S. 68 W., 152 feet to an iron pin on the eastern side of Grand View Circle; thence with said Circle, N. 3-15 W. 165 feet to the point of beginning; being the same conveyed to me by Kenneth Garland by his deed dated April 21, 1966, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 796, at Page 625.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed on July 26, 1963 in the original sum of \$ 12,300.00 by Virgil W. Phillips and Linda C. Phillips in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. Office for Greenville County in Mortgage Book 929, at page 392, on which there is a balance due of \$ 11,352.19 as of this date.
