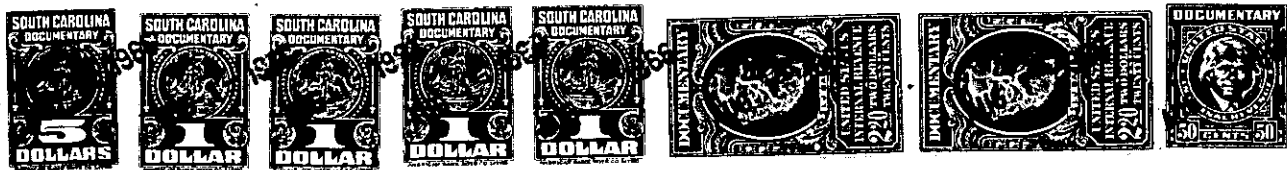
KNOW ALL MEN BY THESE PRESENTS, that Joe E. Hawkins

All that certain lot of land in Greenville County, State of South Carolina, shown as Lot No. 4 on a plat entitled Property of J. T. Merritt, recorded in Plat Book III at page 167, in the RMC Office for Greenville County, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Hardwick Drive at the joint front corner of Lots 4 and 9; thence with said Drive N. 41-30 W. 125 feet to an iron pin at the corner of Hardwick Drive and Wardview Avenue; thence with the curve of said corner, the chord of which is N. 86-30 W. 28.3 feet to an iron pin on the Southeastern side of Wardview Avenue; thence with the Southeastern side of Wardview Avenue, S. 48-30 W. 105 feet to an iron pin at the front corner of Lot 5; thence with the line of Lot 5, S. 41-30 E. 145.2 feet to an iron pin at the rear corner of Lot 9; thence with the line of Lot 9, N. 48-30 E. 125.2 feet to the Beginning corner.
