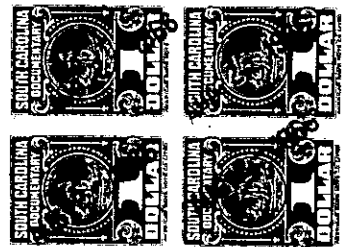

KNOW ALL MEN BY THESE PRESENTS, that We, Julian C. Bolt and Jounaud J. Bolt,

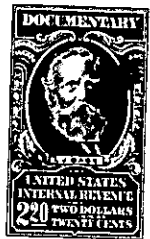

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lewis W. Hazle, his heirs and assigns, forever.

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #3,, of a subdivision known as Dogwood Terrace, as shown on a plat prepared by J. Mac Richardson, Engineer, dated May 1960, and recorded in the R.M.C. Office for Greenville County in Plat Book UU, at Page 5, and having, according to said plat, the following metes and bounds:



BEGINNING at an iron pin on the western side of Edwards Road, the joint front corner of lots #3 and #2, and running thence along the line of these lots, S. 84-06 W. 180.2 feet to an iron pin in the line of Lot #4; running thence along the line of said lot, N. 0-51 W. 141 feet to an iron pin on the southern side of Indian Trail; running thence along the southern edge of Indian Trail, S. 81-07 E. 159 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 40-54 E. 30.5 feet to an iron pin on the western side of Edwards Road; running thence along the western edge of Edwards Road S. 0-40 E. 40 feet to an iron pin; thence continuing along the western edge of Edwards Road, S. 6-10 E. 35 feet to an iron pin, point of beginning.
