has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release, unto the said LeRoy W. Field the following described property, to-wit:

ALL that certain piece, parcel or lot of land with all improvements thereon or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as Lot No. 21 of a subdivision known as Springview as shown on a plat thereof being recorded in the R.M.C.
