the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Christopher G. Trammell, his heirs and assigns:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lots Nos. 20 and 21, Section II, of Westcliffe Subdivision, as shown on a plat thereof prepared by Piedmont Engineers & Architects, December 11, 1963, revised September 24, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at pages 72, 73, 74 and 75, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Westcliffe Way and running thence along the joint line of Lots Nos. 19 and 20 S. 33-00 E. 150.0 feet to an iron pin; thence running along the joint rear line of Lots Nos. 20 and 23 S. 57-00 W. 110.0 feet to an iron pin; thence running along the joint rear line of Lots Nos. 21 and 22 S. 56-34 W. 117.0 feet to an iron pin on Whitehaven Drive; thence running along the said Whitehaven Drive N. 24-00 W. 140.0 feet to an iron pin; thence running N. 18-12 E. 37.0 feet to an iron pin; thence running along the southern side of Westcliffe Way N. 60-24 E. 76.8 feet to an iron pin at the joint front corner of Lots Nos. 20 and 21; thence continuing along the southern side of Westcliffe Way N. 60-24 E. to a point; thence continuing N. 57-00 E. to the point of beginning. (This being the entire side of Lot No. 20 fronting on Westcliffe Way and measuring 100 feet).
