All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 11 of a subdivision known as Chanticleer, Section II, as shown on plat thereof prepared by R. K. Campbell, R. L. S. August 30, 1965, recorded in the R.M.C. Office for Greenville County in Plat Book JJJ, at Page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of East Seven Oaks Drive, joint front corner of Lots Nos. 10 and 11, and running thence along the joint line of said lots, N. 42-41 E. 170 feet to an iron pin; thence N. 39-25 W. 125 feet to an iron pin at the rear corner of Lot No. 12; thence along the line of that lot, S. 43-03 W. 187 feet to an iron pin on the northern edge of East Seven Oaks Drive; thence along the northern edge of East Seven Oaks Drive, S. 46-0 E. 6.2 feet to an iron pin; thence continuing along the northern edge of East Seven Oaks Drive, S. 47-19 E. 118.8 feet to the beginning corner; being the same conveyed to me by Chanticleer Real Estate Company by deed dated April 13, 1966 and recorded in the R.
