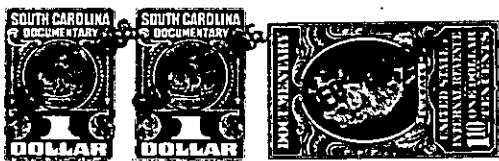
KNOW ALL MEN BY THESE PRESENTS, that I, John E. Galloway
