Janet K. Stafford, her heirs and assigns forever;

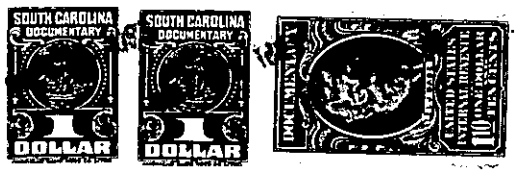

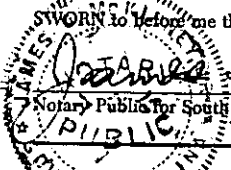
