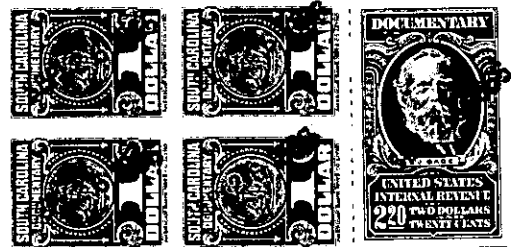

All that certain piece, parcel or lot of land lying and being on the southeasterly side of Theodore Circle, near the City of Greenville, S. C., and being designated as Lot No. 5 on plat entitled "Property of Dempsey Construction Co., Inc., Section No. 2, Carolina Heights", as recorded in the RMC Office for Greenville County, S. C. in Plat Book BBB, page 161, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Theodore Circle, joint front corner of Lots 5 and 6, and running thence along the common line of said Lots S 47-27 E 150 feet to an iron pin; thence S 42-33 W 100 feet to an iron pin, joint rear corner of Lots 4 and 5; thence along the common line of said Lots N 47-27 W 150 feet to an iron pin on Theodore Circle; thence along said Circle N 42-33 E 100 feet to an iron pin, the point of beginning.
