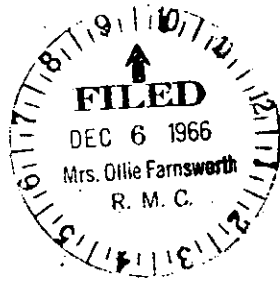

All that piece, parcel or lot of land in Great Township, Greenville County, State of South Carolina, being a portion of that shown on a plat prepared by B. F. Neves, and being more particularly described as follows:

BEGINNING at a stake on County road and running thence N. 9-W. 9.70 <sup>640.20</sup> chains to a stake, thence N. 53 E. 2.55 <sup>169.30</sup> chains to a stake, thence S. 9-E. 9.70 <sup>640.20</sup> feet to a stake on County road, thence along County road N. 87-W. 2.55 <sup>169.40</sup> chains to the point of beginning and containing approximately ten (10) acres more or less. It being the intent of the Grantees to convey to the Grantors approximately ten (10) acres of land.
