unto Rachel W. Floyd, her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 85 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Cashmere Drive, the joint front corner of Lots Nos. 84 and 85, and running thence along the joint line of said lots, S. 28-10 W. 137.9 feet to an iron pin at the joint rear corners of Lots Nos. 82, 84 and 85; thence along the joint line of Lots Nos. 82 and 85, S. 10-49 W. 30 feet to an iron pin on the rear line of Lot No. 115; thence along the rear line of that lot, S. 79-11 E. 50 feet to an iron pin at a rear corner of Lot No. 86; thence along the line of that lot, N. 35-10 E. 137.7 feet to an iron pin on the southwestern side of Cashmere Drive; thence along the southwestern side of Cashmere Drive, N. 50-20 W. 75 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record.
