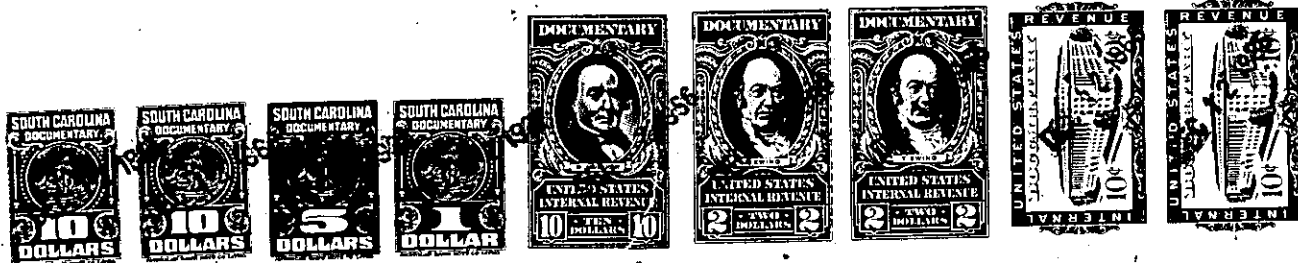
KNOW ALL MEN BY THESE PRESENTS, that HENRY C. HARDING BUILDERS, INC., a corporation chartered under the laws of the State of South Carolina and having its principal place of business in Greenville County, State of South Carolina, in consideration of

Twelve Thousand Nine Hundred Fifty and No/100 ----- (\$12,950.00)--- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto CHARLES R. HUMPHRIES and DORIS W. HUMPHRIES, their heirs and assigns, forever:

ALL that lot of land with improvements lying on the Western side of Gayle Street in Gantt Township in Greenville County, South Carolina, being shown as Lot No. 24 on a Plat of ROCKVALE, Section 1, made by J. Mac Richardson, RLS, dated October, 1958, and recorded in the RMC Office for Greenville County, S. C., in Plat Book 00, page 108, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Gayle Street at the joint front corners of Lots Nos. 24 and 25, and running thence along the line of Lot No. 25, S. 88-02 W., 190 feet to an iron pin; thence N. 1-58 W., 75 feet to an iron pin at the joint rear corners of Lots 23 and 24; thence along the common line of said lots, N. 88-02 E., 190 feet to an iron pin on Gayle Street; thence along the Western side of Gayle Street, S. 1-58 E., 75 feet to an iron pin, the beginning corner.

The above described property is the same conveyed to the Grantor by deed of American Mortgage and Investment Co., by deed recorded in the RMC Office for Greenville County, S. C., in Deed Book 806, page 641, and is hereby conveyed subject to restrictions applicable to Rockvale, the rights of way and easements shown on the aforementioned recorded plat and otherwise appearing of public record; and in particular the 10-foot drainage easement and 33 foot Duke Power Company right of way shown on the said plat.
