BEGINNING at an iron pin on the northern side of Eastcliffe Way and running thence along the joint line of Lots Nos. 216 and 217, N. 36-38 W. 165.6 feet to an iron pin; thence running N. 57-20 E. 100.0 feet to an iron pin; thence running along the joint line of Lots Nos. 215 and 216, S. 36-28 E. 170.6 feet to an iron pin on the northern side of Eastcliffe Way; thence running along the said Eastcliffe Way, S. 60-12 W. 100.0 feet to the point of beginning; being the same conveyed to the grantor corporation by I. H. Philpot, Trustee, by deed dated March 3, 1966, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 793, at Page 500.
