BEGINNING at an iron pin on the westerly side of White Horse Road at the joint front corner of lots 1 and 1-A and running thence with the common line of said lots, S. 69-59 W., 190 feet to an iron pin; thence S. 20-01 E., 20 feet to an iron pin; thence N. 69-59 E., 190 feet to an iron pin on the westerly side of White Horse Road; thence with said Road, N. 20-01 W., 20 feet to the point of beginning.

A three-fourth (3/4) interest in the above property is conveyed by the South Carolina National Bank as Trustee under the Will of Pauline B. McHugh, deceased, and the remaining one-fourth (1/4) interest as Successor-Trustee under an agreement with Evelyn McHugh dated November 3,
