An undivided one-sixth interest in all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, situate, lying and being on the West side of South Main Street and being known as Lot # 2 on a Plat recorded in Plat Book C at page 49 and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at a stake on the West side of South Main Street at the joint corner of Lots # 1 and # 2; thence along South Main Street N 35-55 E 21 to a stake at the joint corner of Lots # 2 and # 3; thence along the joint line of said Lots N 58-05 W 36' to a corner; thence along a line parallel with South Main Street S 35-55 W 21' to a stake at the joint corner of Lots # 1 and # 2; thence along the joint line of said Lots S 58-05 E 36:4" to the beginning corner.
