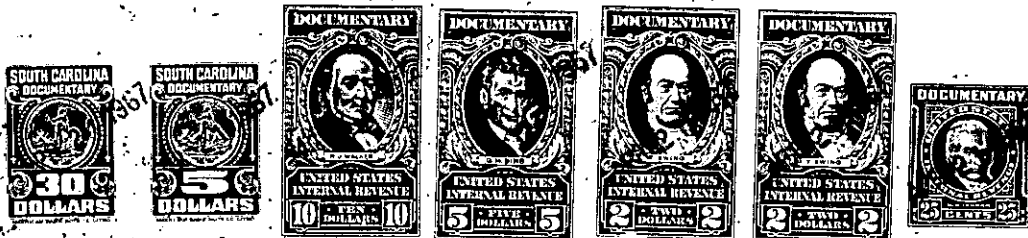
KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County,

in consideration of Seventeen Thousand, Two Hundred and No/100-----(\$ 17,200.00)--- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Arthur D. Clayton and Constance M. Clayton, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 116 of a subdivision known as Colonial Hills, Section No. 3, as shown on a plat thereof prepared by Piedmont Engineers & Architects, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Woodleigh Drive, joint front corner of Lots 22 and 116, and running thence with the joint line of Lots Nos. 22, 23 and 116, N. 4-27 E. 224.6 feet to an iron pin, joint rear corner of Lots 23 and 116; thence along the rear line of Lots Nos. 25 and 116, S. 80-15 E. 70.0 feet to an iron pin, joint rear corner of Lots 115 and 116; thence with the joint line of said lots, S. 11-01 E. 188.8 feet to an iron pin on the northern side of Woodleigh Drive, joint front corner of said lots; thence with said drive, S. 77-41 W. 125.0 feet to an iron pin, the point of beginning; being the same conveyed to me by Williams Land Company, Inc., same as Williams Land Co., by deed dated February 16, 1967, and recorded in the R. M. C. Office for Greenville County.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
