

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northeasterly side of Monaview Circle (formerly Floyd Street), near the City of Greenville, S. C., being known and designated as Lot No. 1 on plat of property of J. P. Stevens & Co., Inc., as recorded in the RMC Office for Greenville County, S.
