To have and to hold, all and singular the said premises before mentioned unto the Buyer, Fennell and Kinard , h is heirs and assigns forever. 3. That the said Seller has and does hereby grant unto the said Buyer free right and license to enter upon the said premises or other premises of the said Seller adjoining thereto at any undiall times from the day following the date hereof for and until the expiration of Sixteen months (9/4/68) years next hereafter ensuing, with such workman, teams and apparatus as may be necessary or proper for cutting, transporting or manufacturing said lumber and to cut and carry away the same.
