All those lots or parcels of land more particularly described in the deed from Grace Chamblee Woods, et al, to William Chamblee, Jr., dated June 4, 1951, recorded in Book 436 at Page 272, said tract of land being the same lands described in the deed from V. M. Babb, Jr., Trustee of the Estate of W. M. Chamblee, to Grace Chamblee Woods, et al, said deed also dated June 4, 1951, recorded in Book 436 at Page 278. LESS AND EXCEPT that portion of said lands conveyed by W. M. Chamblee to H. B. Cooper by deed dated April 5, 1957, recorded in Book 574 at Page 298.

The right of way herein granted and conveyed across the above described tract of land shall have a total width of 150 feet, being 15 feet Northwesterly of, adjacent to, and parallel with the first pipe line constructed by Grantee in 1950, and 135 feet Southeasterly of, adjacent to, and parallel with said first pipe line. During construction of two (2) additional pipe lines upon the aforesaid right of way, 150 feet in width, Grantee shall have the right to clear and use an additional strip of land, 40 feet in width, on the Southeasterly side of aforesaid right of way, 150 feet in width.

It is understood and agreed that Grantee has previously installed three (3) pipe lines under the terms and provisions of previous right of way agreements and that this agreement authorizes the installation of two (2) additional pipe lines within the right of way, 150 feet in width, herein described.
