KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore,

in consideration of - - Seven Hundred Ninety-five and No/100 (\$795.00) - - - - - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Max D. Stone and Helen H. Stone, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 30 as shown on a Plat of Oxford Estates subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book W, at Page 158, and having according to said plat the following description, to-wit:

BEGINNING on Caroline Street at an iron pin at joint front corners of Lots 29 and 30 and running thence 79 feet with the line of said Street to an iron pin at joint front corners of lots 30 and 31; running thence 198.7 feet with the side line of lot 31 to an iron pin at joint rear corners of lots 30 and 31 and property, now or formerly, belonging to Cochran; running thence 97 feet with the line of Cochran property to an iron pin at joint rear corners of lots 29 and 30; running thence 199.2 feet with the side line of lot 29 to the iron pin at joint front corners of lots 29 and 30 on Caroline Street, the point of beginning.

NO residence to cost less than \$8,500.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 50 feet, or more, frontage; no residence shall be built on any lot nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business building shall be erected on any lots other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for year of 1967.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
