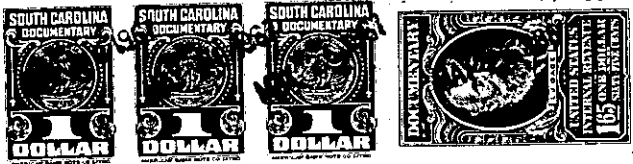
One Thousand Three Hundred Fifty and No/100-----(\$1,350.00)--- Dollars,

ALL that lot of land with improvements lying on the Northern side of Alpha Drive in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 124 on a Plat of KENNEDY PARK, made by Piedmont Engineers & Architects, dated September 28, 1964, revised January 28, 1966, and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 179, and having according to said plat a depth of 133 feet and a width of 75 feet.

The above described property is hereby conveyed subject to rights of way and easements applicable to Kennedy Park shown on the aforementioned recorded plat and appearing of public record, and to restrictive covenants recorded in the RMC Office for Greenville County, S.
