line of the Gantt Station, Greenville Air Base Spur Line, beginning at Station 14 + 36 of said Spur Line; thence North 26° 35' East, 15 feet on the property line dividing the lands of R. C. Simpson and Sue Murray Kern; thence continuing along said property line North 67° 50' West to a point on the north line of said 70 foot right of way; thence Northeasterly along said north right of way with a 4 degree curve to the right to a point on the property line dividing the lands of Mrs. Rosa Mary Cothran and Sue Murray Kern; thence along said property line South 26° 35' West, 40.05 feet to the center line of said Spur Line at Station 15 + 90; thence continuing South 26° 35' West, 40.05 feet to the south line of said 70 foot right of way; thence Northwesterly along said south line of right of way with a 4 degree curve, to the property line dividing the lands of R.
