

is on the property line between the lands of W. H. Willimon, et al., J. C. and Mattie Lee Bailey; thence with a 1 degree curve to the right, 405.0 feet to Station 123 + 34.3 which is on the property line, bearing North 76° 45' East, between the lands of J. C. and Mattie Lee Bailey and James Gregory, being substantially the same land as conveyed by easement from J. C. Bailey and Mattie Lee Bailey to City of Greenville, South Carolina, dated July 9, 1942, and recorded August 8, 1942, Deed Book 246, page 304, Greenville County, containing 0.56 of an acre, more or less.

PARCEL NO. 31 (TRACT NO. 21)

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning at a point on the northern property line now or formerly of James Gregory which is North 76° 45' East 256.31 feet from the northwest corner of said tract; thence along the arc of a curve to the right 50.7 feet to the point of tangent; thence South 26° 15' East 215 feet; thence along the center line of a strip 75 feet wide extended 37-1/2 feet on each side of and parallel to the center line South 26° 15' East 1,312.3 feet to the southern property line of the aforementioned tract which is North 66° 25' East 1,022.5 feet from the southwest corner of said tract; containing 2.22 acres, more or less.

PARCEL NO. 32 (TRACT NO. 20)

A 70 foot right of way, 35 feet on each side of the center line of the Gantt Station Greenville Air Base Railroad Spur Line, beginning at Station 136 + 97.3 of said Spur Line, which station is on the property line, bearing North 66° 25' East, between the lands of James Gregory and Clint Abraham, et al.; thence South 26° 15' East, 707.7 feet to Station 144 + 05, which station is on the property line, bearing South 31° 45' West, between the lands of Clint Abraham, et al., and A. C. Mann, being substantially the same as conveyed by Clint Abraham, et al., to Greenville County, South Carolina, by easement dated July 14, 1942, recorded August 24, 1942, Deed Book 247, page 43, containing 1.13 acres, more or less.

PARCEL NO. 33 (TRACT NO. 19)

A 60 foot right of way, 30 feet on each side of the center line of the Gantt Station, Greenville Air Base Railroad Spur Line, beginning at Station 144 + 05 of said Spur Line, which station is on the property line, bearing North 31° 45' East, between the lands of Alice Abraham and A. C. Mann, thence South 26° 15' East, 295 feet to Station 147 + 00. Also a 70 foot right of way, 35 feet on each side of the center line of the Gantt Station, Greenville Air Force Base Railroad Spur Line, beginning at said Station 147 + 00; thence South 26° 15' East, 770 feet to Station 154 + 70, which station is on the property line, bearing North 87° 30' East, between the lands of A. C. Mann and Betty King, being substantially the same land as conveyed by A. C. Mann to the City of Greenville, South Carolina, by easement dated June 5, 1942, recorded June 11, 1942, Deed Book 245, page 175, containing 1.65 acres, more or less.

PARCEL NO. 34 (TRACT NO. 18)

A right of way along the center line of the Gantt Station, Greenville Air Base Railroad Spur Line, beginning at Station 154 + 70
