All our right, title and interest in and to a certain abandoned roadway, being more particularly shown on plat of J. C. Hill, surveyor, dated December 13, 1966, recorded in Plat Book <u>000</u> at page <u>97</u>, RMC Office for Green-ville County. The area conveyed is the Western area of a roadway shown on the above plat beginning at the Western side of said roadway at a line marked PL, the center line of the roadway is described as follows:

BEGINNING at said point, thence N. 27-50 W. 200 feet more or less to a bend; thence N. 2-15 W. 52 feet to the bend; thence N. 9-50 E. 223 feet to a bend; thence N. 1 W. 224 feet to a bend; thence N. 18-40 E. 20 feet more or cless to the Southern boundary of a new road, which is being deeded by the grantors to Greenville County by deed of even date herewith. The width of this road is approximately 25 feet each side of the center line and said roadway has been closed and abandoned.
It is the intention of the grantors to convey to the grantee only one-half of the roadway which is being abandoned, which will be the one-half west of the center line that is above described. The grantees will retain the remaining one-half of said roadway. The above described property is located within the corporate limits of the City of Greenville, South Carolina.
