

All that certain piece, parcel or lot of land situate, Lying and being on the Western side of Wellington Drive, in the Town of Mauldin, County of Greenville, State of South Carolina, being known and designated as Lot 49 on a plat of "Addition to Knollwood Heights" dated June 2, 1966, prepared by Piedmont Engineers and Architects and recorded in the R.M.C.
