KNOW ALL MEN BY THESE PRESENTS, that I, L. Anita Richbourg Saxon

in consideration of FOUR THOUSAND FOUR HUNDRED and NO/100 (\$4,400.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto EDWARD J. JASKWHICH and DOROTHY W. JASKWHICH, their heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot No. Thirty Seven (37), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the RMC Office for said County and State in Plat Book "EE", at Pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the southwestern side of Richbourg Road as shown on said plat at the corner common to Lots 37 and 38, and running thence S. 55-58 W. along the dividing line between 37 and 38, 215.8 feet to an iron pin at the corner of Lot 38; thence S. 42-52 E. along the dividing line between Lots 37 and Jaskwich, 320.0 feet more or less to center of branch; thence in a north-westerly direction along center of branch 200.0 feet, more or less, to an iron pin; thence along Richbourg Road N. 40-32 W. 265.0 feet, more or less, to the point of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the RMC Office for said County and State in Deed Book 470, at Page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restriction: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed."

This is the same property conveyed to the grantor herein by deed of Lide L. Richbourg and Lila M. Richbourg dated February 16, 1955, recorded in the RMC Office for Greenville County in Deed Book 518, at Page 431, February 17, 1955



together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
