All that piece, parcel or tract of land in Greenville Township, Greenville County, State of South Carolina, on the South side of Tenth Street, in Section No. 5 of Judson Mills Village, being known and designated as Lot No. 51, as shown on Plat of Section No. 5 of Judson Mills Village made by Dalton and Neves, Engineers, in February 1940, which plat is recorded in the R.M.C.
