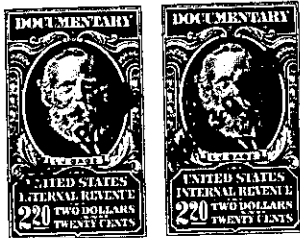
HOWARD D. ROGERS, JR., HIS HEIRS AND ASSIGNS, FOREVER:
