An undivided Thirty (30%) Per-Cent interest in and to the following described real estate.

ALL that certain piece, parcel or tract of land containing approximately '17 acres more or less situate, lying and being on the south side of White Horse Road and Saluda Dam Road in Greenville Township, County of Greenville, State of South Carolina and having the following description:

BEGINNING at an iron pin in the center of White Horse Road and running thence S 39-1/2 W 574 feet to a point; thence N 80-30' W 244 feet to a point; thence S 7-07 E 291.2 feet to a point; thence S 39-1/2 W 684.3 feet to a point; thence N 49-3/4 E 392 feet to a point; thence N 29 - 3/4 E 1260 feet more or less to a point in the center of Saluda Dam Road; thence along the center of the Saluda Dam Road and the center of White Horse Road in a generally Easternly direction 620 feet more or less to the point and place of beginning.
